- Political responsibility of the IGC is entrusted to the foreign ministers sitting in the General Affairs Council. The Commission takes part in this work.

- The IGC's work is done at three levels:

1) Preparatory group: made up of government representatives of the Member States, tasked with preparing ministerial meetings. Two observers from the European Parliament are present at the meetings.

2) Ministerial meeting: this is held on the margins of the General Affairs Council. Every ministerial meeting is preceded by an exchange of views with the President of the European Parliament, assisted by two representatives.

3) European Council: decisions are taken at the level of Heads of State or Government.

In order to speed up the negotiation procedure, the French presidency added a 4th level: the ministerial conclave.
