## **Council Decision of 4 June 1973 accepting the request from the Secretary-General of the Council to relinquish his duties and conferring honorary status upon him**

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Coal and Steel Community;

Having regard to the Treaty establishing the European Economic Community;

Having regard to the Treaty establishing the European Atomic Energy Community;

Having regard to the Staff Regulations of officials of the European Communities as laid down by Regulation (EEC, Euratom, ECSC) No 259/68 and in particular Article 54 of the said Staff Regulations;

Having regard to the Regulation (Euratom, ECSC, EEC) No 2530/72 of the Council of 4 December 1972 introducing special and temporary measures applicable to the recruitment of officials of the European Communities in consequence of the accession of new Member States, and for the termination of service of officials of those Communities, and in particular Article 2 (1) and (3) thereof;

Having regard to the Council Decisions of 14 May 1962 and 12 June 1962 determining the appointing authority for the Secretariat of the Councils;

Whereas, in a letter dated 5 April 1973, Mr Christian CALMES, Secretary-General of the Council, requested to be released from his duties in application of the provisions of Regulation No 2530/72,

HAS DECIDED AS FOLLOWS:

### **Article 1**

On 15 June 1973, Mr Christian CALMES, Minister Plenipotentiary, Secretary-General of the Council, shall relinquish his duties under the conditions laid down in Regulation No 2530/72 of the Council.

### **Article 2**

On the same date, Mr Christian CALMES shall be appointed honorary Secretary-General of the Council of the European Communities.
