This part of the course will give an overview of what to find where in the basic Treaties.

1. TEU and TFEU

The Treaty on the European Union consists of:

- Declaration of goals including ‘an ever closer Union of the peoples of Europe’, and fundamentals such as democracy, dignity of human beings, equality ... (Art. 1, 2, 3 TEU)
- General provisions on distribution of powers between EU and MS, foundational principles such as conferral, subsidiarity, proportionality and protection of human rights (Art. 4, 5)
- Provisions concerning the democratic principle (Art. 9-12)
- Basic provisions concerning the institutions (Art. 13-19)
- Provisions on enhanced cooperation (Art. 20)
- Provisions on the Union’s external action and specific provisions on the Union’s Common Foreign and Security Policy (Art. 21-46)

TFEU – An overview (1)

The TFEU lays down rules governing the institutions and decision-making procedures. It includes provisions on and the legal basis for action in the following policy areas:

- General principles of the EU, e.g.
 - Limited allocation of powers / attribution limitée de compétences / begrenzte Einzelermächtigung
 - Proportionality / proportionalité / Verhältnismäßigkeit
 - Subsidiarity / subsidiarité / Subsidiarität
 - Non-discrimination / Diskriminierungsverbot
- Establishment of EU citizenship.

TFEU – An overview (2)

- Rules on fundamental freedoms / libertés fondamentales / Grundfreiheiten in the EU:
 - Free movement of goods / libre circulation des marchandises / Warenverkehrsfreiheit, Customs Union and the prohibition of quantitative restrictions between Member States (Article 30 et seq. TFEU).
 - Free movement of persons / libre circulation des personnes / Personenfreizügigkeit (originally only free movement of workers / libre circulation des travailleurs / Arbeitnehmerfreizügigkeit) (Articles 45 et seq. read in conjunction with Articles 20 et seq. TFEU).
 - Right of establishment / droit d'établissement / Niederlassungsrecht (Articles 49 et seq. TFEU).
 - Freedom to provide services / libre prestation des services / Dienstleistungsfreiheit (Articles 56 et seq. TFEU).
 - Free movement of capital / libre circulation des capitaux / Kapitalverkehrsfreiheit (Articles 63 et seq. TFEU).

TFEU – An overview (3)

Common rules on competition, taxation and approximation of laws:

- Rules on competition (antitrust) / droit de la concurrence / Wettbewerbsrecht (Articles 101 et seq. TFEU).
- Aids granted by States / aides accordées par les Etats / Staatliche Beihilfen (Articles 107 et seq. TFEU).
- Tax provisions / dispositions fiscales / Steuerregelungen (Articles 110 et seq. EC).
- Approximation of laws/rapprochement des législations / Rechtsangleichung (Articles 115 et seq. TFEU).

Rules on economic and monetary policy:

- Economic policy / politique économique / Wirtschaftspolitik (Articles 120 et seq. TFEU).
- Monetary policy / politique monétaire / Geldpolitik (euro) (Articles 127 et seq. TFEU).
- Institutional provisions / dispositions institutionnelles / institutionelle Vorschriften (ECB, ESCB) (Articles 282 et seq. TFEU).

TFEU – An overview (4)

Legal basis and rules on single policy matters such as:

- Agriculture
- Area of Freedom, Security and Justice
- Transport
- Employment
- Common commercial policy (especially external trade)
- Customs cooperation
- Social provisions
- The European Social Fund
- Education, vocational training and youth
- Culture
- Public health
- Consumer protection
- Trans-European networks
- Industry
- Economic and social cohesion
- Research and technological development
- Environment
- Development cooperation
- Economic, financial and technical cooperation with third countries

TFEU – An overview (5)

Provisions governing the institutions (Article 13 et seq. TEU):

- The European Parliament (EP) / Parlement européen (PE) / Europäisches Parlament (EP) (Articles 14 TEU and 223 et seq. TFEU).
- The European Council / Conseil européen / Europäisches Rat (Articles 15 TEU and 235-236 TFEU)
- The Council / Conseil / Rat (Articles 16 and 237 et seq. TFEU).
- The Commission (Articles 17 TEU and 244 et seq. TFEU).
- The Court of Justice / Cour de justice / Gerichtshof (Articles 19 TEU and 251 et seq. TFEU).
- The European Central Bank / Banque centrale européenne (Articles 282-284 TFEU)
- The Court of Auditors / Cour des comptes / Rechnungshof (Articles 285-287 et seq. TFEU).

Provisions governing the other bodies:

- The High Representative of the Union for Foreign Affairs and Security Policy (Article 18 TEU)
- The European Economic and Social Committee / Comité économique et social / Wirtschafts- und Sozialausschuß (Articles 301 et seq. TFEU).
- The Committee of the Regions / Comité des régions / Regionalausschuß (Articles 305 et seq. TFEU).
- The European Investment Bank / Banque européenne d'investissement / Europäische Investitionsbank (Articles 308-309 TFEU).

2. CFR

Article 6 (1) TEU:

'The Union recognises the rights, freedoms and principles set out in the Charter of Fundamental Rights of the European Union of 7 December 2000, as adapted at Strasbourg, on 12 December 2007, **which shall have the same legal value as the Treaties.**'

The CFR therefore is part of primary law of the EU.
Consequences:

- In case of conflict, TEU, TFEU and CFR provisions have equal value – they will need to be balanced to give each provision its utmost 'effet utile'.
- Normal rules of interpretation (*lex specialis derogat legi generali*, broad interpretation of a rule – narrow interpretation of an exception etc.) are applicable in their relation.
